

## **TERMS & CONDITIONS:**

- 1. Fee should be paid on quarterly basis for each session on or before **10th of April, July, Oct, and Jan** respectively failing which parents will be liable for delayed payment charges.
- 2. If paid in lumpsum before beginning of the session, an additional rebate of 5% will be given on the composite fees
- 3. Transportation and food facility(optional) should be opted at the time of admission or must be applied at least one month in advance before the respective quarter starts.
- 4. Composite Fee structure covers charges for academic and nonacademic learnings, facilities, infrastructures, security, administrative, operations & maintenance, etc. costs excluding annual events, educational trips etc.
- 5. Our transportation and food charges for the full year is equally divided into twelve months.
- 6. Composite fee excludes optional facilities like transport/ food/ Edu-cursions/ camps etc. Once opted will be charged separately as per the prescribed rates.
- 7. Uniforms and stationery are not part of this fee structure.
- 8. Various Examinations conducted by National & International external agencies will be charged separately(optional).
- 9. School fees shall be paid only through any one of the following modes.
  - \* By Cheque
  - \* By Card- Debit & Credit
  - \* By UPI method

### 10. Refund Policy-

a) Any student before attending the classes would like to withdraw the admission then,

Rs 20,000 will be deducted from the composite fees.

Caution Money in total will be refunded or adjusted against any due.

### b) Any student after attending the classes would like to withdraw the admission then,

Caution Money will be refunded or adjusted against any due/against any damage.

The fees upto the quarter student is studying will be retained.

School transport and food fees upto which month the student has availed will be retained and rest amount will be refunded.
