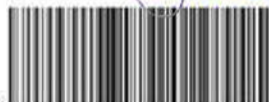

**CONDITIONS:-**

1. 3. The occupiers(s) shall train all staff and occupants periodically to make them well conversant in use and operation of the fire prevention and safety measures.
4. Fire drills/rehearsals should be organised at least once in six months by involving Local Fire Station.
5. The occupier(s) shall appoint Fire Safety Supervisor exclusively for this building or premises.
6. Photocopies of this Certificate should be framed and displayed at all conspicuous places in all lobbies/corridors in all floors of all Towers/Blocks of building/premises.
7. This Certificate is issued under 'One time relaxation scheme' of Odisha Fire Service vide Govt. of Odisha, Home Department Notification no-28550/CD, Bhubaneswar, dtd.28.08.2020. As such the plan shall be approved and the owner/occupier is required to regularize the deviations by the Competent Plan Approving Authority of jurisdiction.
